

Networking sites and supporting the sustainable development of the territories thought cultural tourism: education and structuring cooperation

The first UNESCO/UNITWIN¹ “CULTURE, TOURISM, DEVELOPMENT²” held in Rimini between 21 and 23 September 2007, was realized with the support of Alma Mater Studiorum University of Bologna (Faculty of economics of Rimini High school for tourism sciences), University of Paris 1 Pantheon Sorbonne.

The main topic of this first workshop was “ Networking sites and supporting the sustainable development of the territories thought cultural tourism: tools, education and structuring cooperation.”

The objective of this UNESCO/UNITWIN meeting was:

to work on themes relating to the networking of sites (including World heritage sites) in order to provide the world Heritage Centre, the decision-makers and actors in filed with methods and tools for sustainable territorial management by giving prominence to culture and cultural and natural heritage;

to take stock of the new challenges in distance learning (e-learning) and network’s potential means of establishing a resource centre and an operational skills platform to improve knowledge, offer training for capacity building and be

¹ UNITWIN is the abbreviation for the UNIVERSITY TWINNING and networking scheme. The Programme was established in 1992 following the relevant decision of the General Conference of UNESCO taken at its 26th session.

The UNITWIN/UNESCO Chairs Programme was conceived as a way to advance research, training and programme development in higher education by building university networks and encouraging inter-university cooperation through transfer of knowledge across borders. Since it was set up in 1992 the programme has aroused great interest among Member-States.

Today 631 UNESCO Chairs and 60 UNITWIN Networks are established within the Programme, involving over 770 institutions in 126 countries. The UNITWIN portal contains full information on UNESCO Chairs and UNITWIN Networks covering 70 disciplines and identifies the contact persons, partners, events and publications for each one.

The workshop was organized in three different thematic areas:

- Tourism development and networking cultural sites and route
- The challenges of distance training and e-learning
- Functioning of the network

In each areas the participants discussed about specific key issue that you could find summarized in the following table

More and detailed information of these issues could be found in the final report published from Alma Mater Studiorum University of Bologna and school for tourism sciences, the report was readable in two languages English and France, and it based on preparatory documents, presentation and notes provided by participant.

The report is very useful to understand in which the network's universities partner are thus required to contribute, as Unesco's partners, to the achievement of the objectives and ideals of the United Nations in building a more caring world, in which respect for cultural diversity goes hand with sustainable development in aspiring to peace (H.
